1. **RIGHT TO CANCEL:** The buyer may cancel the contract without penalty within three business days of signing and the buyer receiving a fully completed copy thereof. Within 10 business days of receipt of notice of cancellation under this paragraph, the Winery shall refund to the buyer money paid under the contract. Buyer shall cancel by delivering or mailing by certified mail, return receipt requested, written notice to Salted Vines Vineyard & Winery ("Winery"). The notice must say that you do not wish to be bound by the contract and must be delivered or mailed before 12 midnight of the third business day after you sign and receive a copy of this contract.
2. **GOVERNING LAW:** This Agreement shall be governed by and interpreted in accordance with the laws of the State of Delaware.
3. **COMPLIANCE:** By executing this contract, the buyer agrees to comply with all rules, regulations, policies and procedures as may be established or amended from time to time by the Winery.
